## Attorney Fred Levin Donates Millions Toward Cancer Research

BOSTON, MA – Award-winning attorney and philanthropist Fredric G. Levin was honored by Dana-Farber Cancer Institute for his \$2 million donation to further cancer research. The generous gift will establish the Fredric G. Levin Endowment in Translational Cancer Research and support the Presidential Initiatives Fund through the Pan-Mass Challenge, a bike-a-thon that raises millions of dollars each year for Dana-Farber Cancer Institute.

Mr. Levin and his son, attorney Martin Levin, attended the commemoration celebration in Boston on November 13, along with Levin Papantonio attorney Virginia Buchanan. Other distinguished guests included President of Dana-Farber Cancer Institute, Dr. Laurie Glimcher, and two of the physicians treating Mr. Levin, Dr. Raphael Bueno, Chief of the Division of Thoracic Surgery at Brigham and Women's Hospital, and Dr. David Kozono, a Dana-Farber radiation oncologist who specializes in the treatment of lung cancer.

"As a result of two great institutions getting together with two great doctors I'm still here," said Mr. Levin.

This gift makes for a total of \$4 million in donations Mr. Levin has contributed to the institutions where he was treated for lung cancer. Mr. Levin was diagnosed with lung cancer in January 2016, and his tumor was surgically removed at Brigham and Women's Hospital several months later. In 2017, Mr. Levin donated \$2 million to Brigham and Women's for the establishment of the Fredric G. Levin Distinguished Chair in Thoracic Surgery and Lung Cancer Research. As of the present time, Mr. Levin is cancer-free.

Brigham and Women's Hospital in Boston is affiliated with Harvard Medical School and Dana-Farber Cancer Institute. Mr. Levin's most recent \$2 million donation will go toward research at Dana-Farber.

"This fund will exist in perpetuity and its distribution will support the central tenant of the approach of Dana-Farber to cancer treatment and that is accelerating discoveries in the laboratory into therapies for our patients," said Dr. Glimcher, President of Dana-Farber Cancer Institute. "We can do that at Dana-Farber because of the very close relationship with our researchers, with our clinicians, and our surgeons."

Dr. Kozono's career goal is to improve treatment for patients through clinical investigation and research. He also spoke at Mr. Levin's commemoration, thanking him for his generous contribution that will go toward finding new ways to assist patients.

"The generous support provided by Fred and his family will catalyze our research to understand the differences in how patients respond to treatment," Dr. Kozono said. "I'm particularly excited that one day a single tube of blood may give us all the answers that we need to identify the best treatment for each individual patient. A reliable blood test can go a long way. Fred's kind support will assure that we have the resources to sustain the collection of these indispensable samples and kick start our efforts to profile these samples so they can go towards answering these questions."

Mr. Levin was also honored with a plaque that will be placed at Dana-Farber in the name of his late wife, Marilyn Kapner Levin. The Levin family has long supported the Pan-Mass Challenge bike-a-thon, a popular sporting event that has drawn tens of thousands of cyclists to the New England area for forty years. To date, the Pan-Mass Challenge has raised more than \$700 million, all of which have gone to Dana-Farber Cancer Institute. The event's founder and executive director, Billy Starr, was also at Mr. Levin's commemoration to express his gratitude.

One aspect of Mr. Levin's donations to Brigham and Women's and Dana-Farber is the creation of an annual lung cancer conference to be held for ten years in Mr. Levin's hometown of Pensacola. In the past two years, hundreds of local doctors, nurses,

students, and patients attended the Fredric G. Levin Cancer Symposium, where the top lung cancer physicians and researchers with Brigham and Women's Hospital, Dana-Farber Cancer Institute, and Harvard Medical School come to Pensacola and share their discoveries. The next conference is scheduled for April 2 - 3, 2020 in Pensacola.

Mr. Levin has a long history of generosity, especially in the Northwest Florida community. Among his many other community contributions, Mr. Levin donated his \$8M "Timeless Tanglewood" estate to the University of West Florida, in honor of his late friend and former law partner, Florida's 37th Governor Reubin O'D. Askew. He gave \$1M for the Institute of Human and Machine Cognition's new Levin Center for IHMC Research, another \$500,000 for Downtown Pensacola's YMCA facility, and hundreds of thousands of dollars to Gulf Coast Kid's Home and Sacred Heart Hospital's Miracle Camp.
